Division of Operations

The Division of Operations is the largest unit of the Commission and is comprised of four sections: the Revocations Unit, Victims' Services, Office of the Commission Clerk, and Field Services. Twelve field offices are divided among five regional areas across the state with each region staffed by an Administrator who directs the day-to-day activities of the professionals and support staff assigned to offices located within the region.

Operations is responsible for multiple functions in the administration of post prison supervisory release programs. These supervised release programs include parole, conditional medical release, control release, conditional release, and addiction recovery release supervision. Through its Field Services staff, Operations conducts parole interviews, administrative hearings for alleged violations of supervision, as well as clemency investigations for the Board of Executive Clemency.

Division of Administration

The Division of Administration provides administrative support to the Commission's Central Office and 12 field offices. Administration includes Human Resources, Finance and Accounting, Purchasing, Safety, Grants, Contracts, Inventory, Emergency Management and General Services.

Accomplishments: December 2016

- FCOR achieved 100% prompt payment compliance.
- Submitted 10 requisitions, 17 security requests, 15 purchase requests, 110 invoices, 79 inner office requests, 7 work orders, and made 37 deliveries.
- Submitted a budget amendment for two performance measures.
- Distributed Wellness information.
- Attended Human Resources Officers Meeting, FLSA work group, and FASAAD meetings.
- Participated in the Statewide Travel Management System.
- Updated Travel and P-card Procedure Directive.
- Attended Active Shooter training.
- Established a new process for recycling.
- Scanning project has begun for previous year's vouchers.
- Indexing of Procedure Directives has been completed.
- Revised back all changes to position attributes to over time eligible and FLSA work period.

Office of General Counsel

The Office of the General Counsel is charged with successfully prevailing on litigation filed against the Commission; providing quality legal advice and representation in a prompt manner; and engaging in proactive legal counseling to prevent unnecessary litigation in the future.

Accomplishments: December 2016

During the month of December, the Office of the General Counsel generated thirty-five (35) court filings, including briefs, responses, motions, orders, and notices. The Office of the General Counsel responded to 63 public records requests.

Monthly Accomplishments Report

During the month of December, the Commission received thirty (30) positive orders, from both state circuit and appeals courts and in federal appeals courts. These orders are in the nature of reaffirming long-held and long-standing precedent governing some of the more common challenges presented against the Commission, including the denial of a grant of credit for time out on supervision after a supervision revocation, the placement of an offender on conditional release, the Commission's discretionary authority to impose special conditions in a conditional release order, the Commission's authority to suspend a PPRD, the reasons set forth for a suspension of a PPRD, and the Commission's decision to aggravate for unsatisfactory institutional conduct and its decision not to mitigate based on particular information set forth by an inmate. Inmate petitions for writs of certiorari, for all writs, and for writs of prohibition were denied the District Courts of Appeals.

Office of Legislative Affairs

The Office of Legislative Affairs is charged with overseeing the Commission's legislative program as the agency's chief legislative advocate.

Accomplishments: December 2016

- Attended Executive Office of the Governor Legislative Affairs Director's Meetings.
- Conducted ongoing legislative constituent relations regarding various Commission functions.
- Met with Legislators to help educate and better inform them about the roles of the commission.

Office of Communications

The Office of Communications is charged with overseeing the agency's communications and public information program.

Accomplishments: December 2016

- Provided ongoing media relations and internal employee communication efforts.
- Completed and distributed the Annual Report.
- Provided media assistance at the December clemency hearing.
- Drafted Clemency: By the Numbers fact sheet for clemency hearing.
- Provided Corrections the requirements and specifications for new media and news clips databases.

Office of Executive Clemency

The Office of Executive Clemency (OEC) reports directly to the Governor and Cabinet who sit as the Clemency Board in the performance of their duties and responsibilities. This office is responsible for coordinating all clemency meetings, referring applications for investigation, and serves as the official custodian of all clemency records.

Accomplishments: December 2016

The final clemency meeting of 2016 was held on December 7, where 80 cases were heard. We had 29 applicants appear and several applicants with individuals who spoke on their behalf. The meeting commenced at 8:10 a.m. and adjourned at 11:48 a.m.

The Executive Orders for applicants who were granted clemency were circulated for signatures and will be filed with the Secretary of State. Copies are then mailed to the applicants. The prep work for the next clemency meeting in March 2017 has already begun.

The main goal of the Office of Executive Clemency is to screen the daily submissions of applications in an expeditious manner in order to notify the applicants early on of their status in the first phase of a two-phase process. Detailed correspondence is provided to the applicants explaining the next steps in the process and advising of any additional information that is needed to move forward. Excellent customer service will continue to be a priority.

Office of Clemency Investigations

The Office of Clemency Investigations is charged with investigating, reviewing, evaluating, and reporting to the Clemency Board in all types of clemency cases, including, but not limited to, the restoration of civil rights, restoration of alien status under Florida law, full pardons, firearm authority, commutations of sentence, remission of fines, and capital punishment cases.

Accomplishments: December 2016

- On December 7, 2016, the Governor and Cabinet, sitting collectively as the Clemency Board, held its fourth
 quarterly Clemency Board Meeting. The Commission completed and submitted 80 in-depth clemency
 investigations for consideration by the Board. The Chairman provided detailed information related to the
 Confidential Case Analyses and processes to the Board Members in response to their inquiries.
- On December 8, 2016, training was provided to the Regional Administrators and Supervisors during a conference call to include procedures related to clemency investigations.
- Conducted quality assurance reviews of With and Without a Hearing investigations completed by field offices.
- Conducted investigations on Requests for Review for Commutation of Sentence cases.
- Provided assistance and support related to eligibility determinations and clemency investigation procedures to Field Services staff.
- Provided customer service to clemency applicants and assisted in responses to public records requests and legislative inquires for clemency information/data requests.
